I would like to verify that you have received this email, so I know I have the correct email address for you. *When you receive this message please reply, indicating whether or not you can open the attachments.* If I don't receive this back from you I will assume that you haven't gotten it, and I will need to follow up by telephone to get an alternative email address from you.

If you do not receive any of these attachments or are unable to open any of them, please contact me immediately. They are all important documents that require your review and action. Take special note of the travel insurance link, <http://www.travelex-insurance.com> which is also included in the "Information, Procedures and Timeline" document. *We strongly encourage you to consider travel insurance; either with the company listed or any travel insurance company you may choose. It is quite inexpensive, and you will be protected against unforeseen circumstances which may arise. If you purchase your insurance through Travelex, be sure to use the Regent Location number 09-0279 for best service. Be surprised at how inexpensive it is to insure your trip.*
